Upon the recommendation of the Delegate, Reverend Brian M. Flatley, I am writing to advise you that effective today, August 23, 1996 I am ending your assignment as a member of the team ministry at Saint Stephen Parish in Framingham and placing you temporarily in Unassigned Status. I am assigning you to Saint Luke Institute in Silver Spring, Maryland for a psychological assessment. The effective date of this assignment will be determined by Father Flatley in light of his conversation with Saint Luke Institute and you. I direct you to be in contact with Father Flatley by September 6, 1996 to initiate this conversation.

It is my sincere hope that you will accept this assignment willingly in a spirit of obedience. However, I must inform you that this letter should be viewed as a warning. If you do not accept this assignment, it will be necessary for me to invoke canonical penalties according to Canon 1371, 2

Please send written notification to Most Reverend William Murphy, Moderator of the Curia, indicating that you have received this communication.
