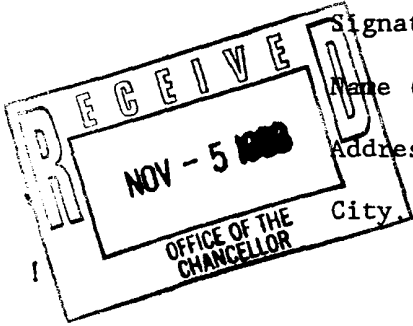

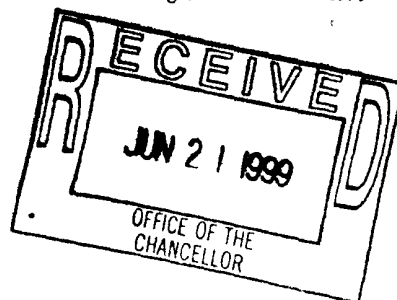

This is my proposed draft for your consideration. I kept it somewhat vague because I do not know who else might see this fax and I want to spare Albert embarrassment.

I felt the need to be forceful about his return because, if he were here in Chicago, we would be taking the matter very seriously because we are now on notice from the Chicago Police Dept. that other minors may be at risk.

It is in Albert's best interest to return, otherwise he will earn the status of a fugitive and returning to Chicago in the future to see his family (all of whom live here) will be extremely risky.

The police regard this as an urgent matter because they find the alleged victim to be credible. Upon his return to Chicago, Dan Coughlin or I will obtain legal representation for Albert and be with him as he participates in the investigation.

It is imperative that you return to Chicago within the next few days to answer some questions involving St. Prissilla Parish. I realize you are participating in a sabbatical that concludes on March 31st. Due to the urgency of this matter, I must request that you terminate your sabbatical and return as soon as possible.

This request may not prove convenient but, under obedience, I ask that you comply with my wishes. Upon your return to Chicago, you are to contact Fr. Larry McBrady or Fr. Dan Coughlin, the Vicars for Priests.

If you wish to discuss this matter with me, you may call me at the residence [REDACTED] [REDACTED] or my office [REDACTED]. Please understand, however, that my request is non-negotiable.

On Wednesday, February 23, John O'Malley and I had a telephone conference call with Sgt. [REDACTED] of the Chicago Police Department regarding a CPD request that the Archdiocese ask Albert to return to Chicago immediately for questioning by the police.

John and I pointed out that on previous occasions Albert has expressed an interest in being permanently assigned to the Philippines. We felt that such a request might encourage him to stay in the Philippines beyond the deadline for the conclusion of his sabbatical, which is March 31, 2000.

This morning I was informed by John that it is the position of the State's Attorney's Office that we should not take any action but to wait for Albert to return to Chicago on or about March 31.

I will inform John Cunningham, pastor of St. Priscilla Parish that we will not be taking any action. I will ask John to inform Dan Coughlin or me of any information pertaining to Albert's return. When Albert returns to Chicago, John Cunningham will notify this office and we in turn will notify John O'Malley, who will in turn notify the CPD.

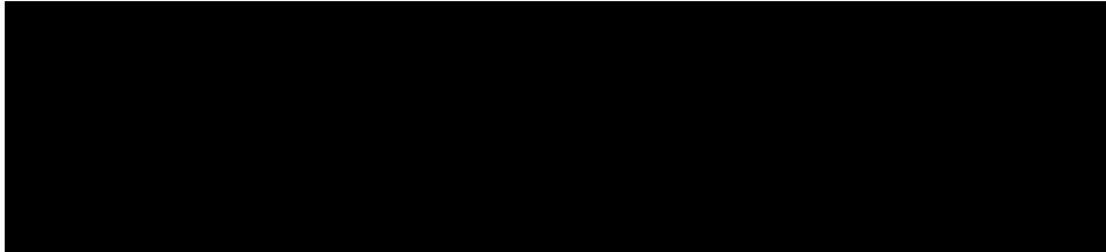

Father Albert Tanghal –

As you know, Albert has unilaterally extended his sabbatical until approximately April 29. John O'Malley and I have been in contact with the Chicago Police Department, the State's Attorney's Office and the Department of Children and Family Services. Each of these agencies is aware of our desire to be fully cooperative. The State's Attorney's Office is recommending that we maintain our course of action allowing Albert to return voluntarily. They are not requesting that any action be taken to order him back to the diocese.

On Friday morning, April 28th, there was a message on my voice mail from John Cunningham advising me that Albert had returned to St. Priscilla Rectory late on Thursday afternoon. I called Albert and we agreed that I would come out to see him. I told him that it concerned a very important matter.

I arrived at the rectory at 11:30 a.m. I met with Albert in his suite on the second floor. Albert was somewhat immobilized by a problem with his foot. I informed him that an allegation of sexual misconduct with a minor had been brought against him and the police and DCFS were each eager to speak with him. Albert asked who made the accusation. I said I did not know the name but that it was a young man who worked in the rectory. Albert knew immediately of whom I was speaking.

After a half-hearted denial, he admitted that, on one occasion, he performed oral sex on the sixteen year-old and had the boy perform oral sex on him. He blamed the young man saying he had put a lot of pressure on Albert to become sexually involved. Albert said he very much regretted his lapse in judgment. He denied that there had been more than one incident.

I told Albert that this was a very serious situation. I mentioned Cindy Giachetti and explained to Albert that he should have legal counsel. I placed a call to Cindy from Albert's room and, when I got Cindy on the line, I explained the situation. Then Albert spoke with her for several minutes. They made plans for a more lengthy phone conversation later that afternoon.

I informed Albert that the Cardinal asked that he cooperate with the authorities. I then asked Albert to leave the rectory because the alleged victim was due to work at the rectory on the following day. I explained the importance of Albert not having any communication with the young man. Albert accepted this and said he could live temporarily at his sister's home in [REDACTED]. He said he would go there right away and gave me her phone number [REDACTED].

I instructed Albert to call me on Friday evening to verify that he was at his sister's and to verify he had been in contact with Cindy Giachetti. We agreed he would contact me daily. By 8 p.m. on Friday evening I had heard nothing from Albert. I called his sister's home and spoke to a young woman who identified herself as Albert's niece. She told me Albert lived in Chicago and that he was not there. At 3:30 p.m. the next day, having heard nothing, I called the sister's home. This time I spoke directly to Albert's sister. She informed me that Albert had stopped by but had gone on to stay with a priest friend. She said she would have him call me. No call ever came. Cindy informed me she never heard anything from Albert.

On May 1st, John O'Malley informed the police department that we did know Albert's whereabouts. [REDACTED]. John furnished the police with Albert's sister's phone number. She told the police he was not there.

Yesterday I informed the Cardinal of Albert's disappearance. The Cardinal was quite surprised. We agreed that, if Albert can be located in the Philippines, the local bishop should be advised that Albert has no faculties. This matter will go to PCAC on May 8th.

It has come to my attention that you have failed to return to your parish ministry from your sabbatical, which expired March 31, 2000. An associate pastor is obliged to attend to the duties assigned to him (canons 274, §2 and 548) and to reside in the parish (c. 550, §1). Negligence to perform one's ministerial duties and violation of the obligation of residence are serious offenses punishable by a just penalty (cc. 1389, §2 and 1396).

Accordingly, as provided by canon 1347, you are warned that failure to return to the Archdiocese of Chicago by June 15, 2000 will result in your suspension as a priest (c. 1333). You are to report to Father Lawrence McBrady, Vicar for Priests.

I pray that you will cooperate and return as requested.

FOR YOUR INFORMATION

Father Abet Tanghal has failed to return to his Parish Ministry here at Saint Priscilla from his sabbatical, which was to have officially ended on March 31, 2000. The Vicar of Priests for the Archdiocese was informed of this situation after Father Abet faxed the Parish that he would not return until April 28, 2000.

During the course of Father Abet's sabbatical, law enforcement officials advised the Archdiocese of Chicago they were conducting an investigation of alleged inappropriate conduct that may involve Father Abet. When Father Abet returned to Chicago briefly last month, he was informed of the investigation. Since that time, Archdiocesan Officials have been unable to contact Father Abet.

Law enforcement officials have not forwarded any other information about their investigation to the Archdiocese, which will continue to cooperate with the authorities. We have no other information about the investigation but if you have any questions or concerns about this matter, please feel free to contact me at the Rectory at your convenience.

The Office of the Chancellor advises all Pastors, Pastoral Coordinators, and Parish Staff members as follows:

Father Tanghal failed to return to his parish after his sabbatical ended on March 31, 2000, and he is now absent without permission from the Archdiocese. During his sabbatical, law enforcement officials advised us that they were conducting an investigation of alleged inappropriate conduct that may involve Father Tanghal. When Father Tanghal returned to Chicago briefly in May, he was informed of the investigation, and since that time, his whereabouts are unknown and we have been unable to contact him. Any person with information regarding Father Tanghal or his whereabouts should immediately contact Father Lawrence McBrady, Vicar for Priests, at

3. Recently, local newspapers have reported that the “Evangelical Catholic Diocese of the Northwest” plans to open a treatment center for individuals with HIV and AIDS on the city’s Southeast side in December. While the “Evangelical Catholic Church” does not claim affiliation with the Archdiocese of Chicago, the Office of the Chancellor nonetheless wishes to clarify that this treatment center is not connected with similar efforts sponsored by the Roman Catholic Church, such as Bonaventure House.
4. The Diocese of Cleveland has asked us to reiterate a previous warning about “**Holy Love Ministries,**” a.k.a., the “**Missionary Servants of Holy Love,**” “**Our Lady Protectress of the Faith Movement,**” “**Project Mercy,**” and “**Mary’s House of Prayer.**” This group continues to seek funds to develop their center and support their effort, and the Diocese of Cleveland cautions that this organization is operating without the approval or support of the local ordinary. In a meeting held with diocesan officials, leaders of Holy Love Ministries made it clear that although they encourage Catholic practices, the ministry is ecumenical, and therefore not subject to the authority of the Church. *Recent publicity regarding reported “apparitions” and “messages” makes it necessary to urge extreme caution in giving credence to such claims.* Some Catholic groups from the Chicago area have apparently been traveling to Cleveland to visit the “apparition site,” presuming it is Catholic. Pastors or parish staff needing further information should contact the Chancellor of the Diocese of Cleveland, Fr. Ralph Wiatrowski, at 216-696-6525, x2080.
5. The Archdiocese of Boston asks all parishes to be advised of the suspension of **Father Gary Fernandez** from priestly ministry and the fact that he is impeded from the exercise of Orders as of May 11, 2000. Fr. Fernandez, a priest of the Archdiocese of Boston, is absent without permission from the Archdiocese, and his whereabouts are currently unknown. Any parish approached by Fr. Fernandez should contact the Office of the Chancellor immediately.

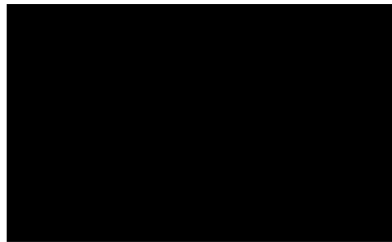

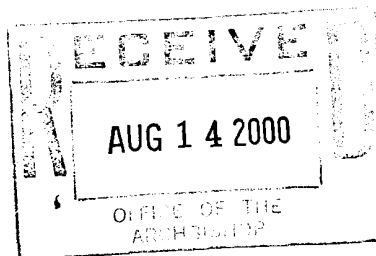

This is to inform Your Eminence that one of your priests, **FR. ALBERT TANGHAL**, has been staying in the Archdiocese of Manila since May 2000. He informed me that he spent his sabbatical year (October 1999-March 2000) in the Philippines in their maternal home in Gagalangin, Tondo, Manila. During such period, he took up some courses and was permitted by his home pastor to assist in the Mass celebrations. I was just alarmed that for a long time, he has not reported to me for registration as guest priest in the Archdiocese.

In my talk with him, he mentioned that he is on **AWOL** (absence without leave) from your archdiocese, due to a threat of legal suit against him involving a male student worker. He denied any truth to the possible charge. In the meantime, he expressed his desire to work here as Guest Priest, but I required him to notify your Eminence first and secure the needed papers or documentations. He is obviously hesitant to do so. I could sense that there is an existing problem; perhaps you could inform me as to the nature of his difficulty. I am initially inclined not to accept him as guest priest in Manila. However, you could enlighten me on his status. This is also to let you know of his whereabouts. I told him that I will communicate with you out of sense of duty. He still seems hesitant that I should do it, and he seems not intent to communicate with you in turn.

Thank you for the kind attention. I hope to hear from you about Fr. Tanghal's situation so that we could assist him in some way or the other. May God's best blessings be with you and your ministry.

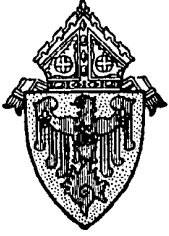
I discussed the contents of Bishop [REDACTED] letter with Cardinal George tonight.

- 1) With regard to the civil authorities, the Cardinal expects us to cooperate and suggests that we (presumably John O'Malley) simply notify the ~~police~~ ^{State's Attorney} that we have received word from a source we consider quite reliable that Father Tanghal is presently living in Manila, but we have no address. The fact that the Bishop's letter to Cardinal George was stamped "Confidential" would preclude us from revealing his name, etc.
- 2) With regard to Bishop [REDACTED] inquiry concerning Tanghal's status, the Cardinal thinks we should:
 - a) tell him that Tanghal is suspended from all ministry due to his refusal to return to his assignment; and
 - b) we should tell him the nature of the allegation made against Tanghal; and
 - c) we should make it clear that we do not know whether or not the allegation is true and to what extent. The allegation was made by the victim in a police investigation of child abuse on the part of a Scoutmaster. In the course of his testimony the victim alleged that Tanghal was also guilty of similar abuse. Because of this the police are searching for Tanghal. No allegation has been made directly to any church authority.

Your Excellency:

Thank you for your letter of July 28, 2000 regarding Fr. Albert Tanghal. I appreciate you contacting me concerning Fr. Tanghal's whereabouts. He is indeed absent without permission.

It was necessary for me to suspend Fr. Tanghal from all priestly ministry effective June 17, 2000 due to his failure to communicate his whereabouts.

As you know, Fr. Tanghal spent his recent sabbatical in Manila. When he returned to the United States on April 28th, he was informed that the police wanted to speak with him concerning an allegation by a sixteen-year-old male. This young man who worked at Fr. Tanghal's rectory alleged that, prior to his sabbatical, Fr. Tanghal engaged in oral sex with him on several occasions.

Father Tanghal was informed of this allegation within hours after his return from Manila by my Vicar for Priests. While I do not know whether or not the accuser is being truthful, I did ask Fr. Tanghal to cooperate with the authorities. Father Tanghal immediately disappeared and all our attempts to contact him have been unsuccessful. The fact that he left this jurisdiction and was unwilling to answer the questions of the police is a matter for deep concern. Under these circumstances I am unable to recommend Fr. Tanghal for service as a Guest Priest in your diocese.

Thank you for your assistance in this matter. I am grateful for the information you provided. You are remembered in my prayers, please keep me in yours.

Former Chicago priest slain in Philippines

Stabbed to death at home in apparent robbery attempt

A former Chicago priest who was living in his native Philippines was found stabbed to death in his suburban Manila home earlier this week, police said.

The Rev. Albert Tanghal Rimando, 50, a parish priest of the Malate Catholic Church in Manila, was lying in a pool of blood with multiple stab wounds in his home in Quezon City when his cousin found him late Tuesday, police said.

Police officer Rogelio Basbas said the case was initially being treated as robbery with homicide.

According to the Philippine Daily Inquirer, police said Rimando was killed Tuesday morning after robbers accosted him coming out of the bathroom. His naked body was found with several stab wounds in the chest and elsewhere.

Police said the home was burglarized three weeks earlier and that robbery was the motive for this crime. According to the paper, the priest's relatives are refusing to cooperate with police or talk with the media.

Rimando was ordained in 1991 and began serving as a priest in the Chicago archdiocese at Our Lady of Ransom in Niles and then at St. Leonard in Berwyn. His last assignment here was at St. Priscilla on the Northwest Side.

A spokesman for the archdiocese said they learned about the murder Thursday.

Jim Dwyer said the archdiocese lost touch with the priest in autumn 1999, when he requested a leave of absence from his parish. He was granted the leave and was scheduled to return to the parish in early 2000, but he never showed.

"He was a nice man," said Fred Spitzzeri, a deacon at St. Priscilla, who worked alongside Rimando on the altar.

Spitzzeri said the priest was especially close to the Philippine community in Chicago. Although there wasn't a large Philippine population near the church, Filipinos from all over Chicago would visit the parish because of Rimando, Spitzzeri said.
